Its current focus is to continue to identify and potentially acquire additional property interests, assess their potential and engage in exploration activities. The company is pleased to report that it has optioned the Wildcat Property and after last years work program, the company has received the results from the MMI sampling report and is working with the geologists to plan the work program on the property for the upcoming season.

The Issuer's business and operations during the month of April 2024 was primarily involved in discussions with geologists for reviewing work done and additional planning for the continuing of the Phase 1 of the work program.

During the month of April 2024, management's principal activities consisted of:

Communications and dealing with administrative matters as related to coordinating the an amendment to the option agreement on the property.

The Issuer was in discussions with geologists and contractors and the owner of the Wildcat property to determine when additional work should be done based on the possibility of obtaining an extension on the option agreement and continuing to develop the property.

The Issuer is also in discussions with the property owner to amend the option agreement as it is in default due to not being able to make the most recent option payment.

The Issuer continued discussions for the potential transaction to acquire Premier Silver Inc. and the Mallay Mine located in Peru.
